# **SECTION 4 - FIRST AID MEASURES**

#### 4.1 Description of first aid measures

**Inhalation:** If product mist or vapor causes respiratory irritation or distress, move the exposed person to fresh air immediately. If breathing is difficult or irregular, administer oxygen; if respiratory arrest occurs, start artificial respiration by trained personnel. Loosen tight fitting clothing such as a collar, tie, belt or waistband. If symptoms persist, seek medical attention.

**Eyes:** Immediately flush eyes with large amounts of water for at least 15 minutes, holding the eyes open with finger tips and occasionally lifting the upper and lower lids. Use lukewarm water if possible. Remove contact lenses, if present and easy to do, after the first 2 minutes and continue rinsing, If eye irritation persists, seek medical attention, preferably from an ophthalmologist.

**Skin:** Flush skin with large amounts of water while removing contaminated clothing and continue rinsing for at least 15 minutes. Use lukewarm water, if possible. Wash contaminated clothing and shoes thoroughly before reuse. If skin irritation persists or if rash develops, seek medical attention.

**Ingestion:** Rinse mouth thoroughly with water if the victim is conscious. Remove dentures, if any. Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious or convulsing person. Do not leave the victim unattended. Seek immediate medical attention.

#### 4.2 Most important symptoms and effects, both acute and delayed

#### Potential health symptoms and effects

Eyes: Causes eye irritation. Symptoms may include redness, swelling, stinging and tearing.

**Skin:** May cause skin irritation. Symptoms include localized redness, itching and discomfort. May cause skin rash in susceptible individuals. **Inhalation:** Mist or vapor may cause irritation of the nose, throat and respiratory tract. Symptoms may include sore throat, coughing, headache, nausea and shortness of breath.

**Ingestion:** May cause gastrointestinal irritation with nausea, abdominal pain, vomiting and diarrhea. May cause headache and dizziness. Repeated ingestion may be harmful.

Chronic: Pre-existing disorders of the skin and respiratory system may be aggravated by exposure to this product.

# 5.2 Special hazards arising from the substance or mixture

Closed containers may explode due to the buildup of pressure when exposed to extreme heat. During emergency conditions overexposure to decomposition products may cause a health hazard. Symptoms may not be immediately apparent or may be delayed. Obtain medical attention.

#### 5.3 Advice for firefighters

Full protective equipment including self-contained breathing apparatus should be used. # **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

#### 6.1 Personal precautions, protective equipment and emergency procedures

#### 7.1 Precautions for safe handling

Store in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10.5), food and drink. Transfer only to approved containers having correct labeling. Keep containers tightly closed. Keep from freezing. Protect containers against physical damage. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Containers of this material may be hazardous when empty as they contain product residue. Use appropriate containment to avoid environmental contamination. Ventilate closed areas. Do not take internally. Keep out of reach of children.
